### HOW WILL THE PUBLIC BENEFIT?

**1** What is the purpose and the duties of the new program, agency, services, or population served? JR4-2-404(4)(c)(i)

The purpose is to create and implement a Firearm Safety Program including producing and distributing a firearm safety brochure and packet, procuring and distributing cable style gun locks, and administering a redeemable coupon program in which a Utah resident who has filed an application for a concealed firearm permit receives a redeemable coupon toward the purchase of a gun safe and receives a firearm safety brochure.

**2** What services are provided by the funding increase? JR4-2-404(4)(c)(ii)

Services include the development/adoption of firearm safety information for a brochure and packet for distribution, the procurement and distribution of cable style gun locks to Utah residents, and a coupon program for concealed firearm permit holders to go towards purchase of a gun safe.

**3** What are the expected outcomes of the new or expanded program and how will the public benefit? JR4-2-404(4)(c)(iii)

- \*Increased public knowledge of safe firearm storage practices
- \*Increased public access to methods for safe storage of firearms (ie cable locks)
- \*Increase partnership between public/private entities to reduce accidental and self-inflicted firearm injuries and deaths.

**4** How will the bill be implemented and what resources are available to achieve the expected outcomes? JR4-2-404(4)(c)(iv)

The state suicide prevention coordinator shall consult with the violence and injury prevention coordinator to implement the firearm safety program and a representative from a nonprofit organization with expertise in the field of firearm safety that represents firearm owners to develop and implement the firearm safety program. Funding from the \_\_\_\_\_ fund will be used to administer this program along with already allocated staff time from the Dept. of Human Services and the Dept. of Health.

**5** How will the proposed agency activities cause the expected outcomes and public benefit in 3?

Increased public knowledge of safe firearm storage practices will be accomplished by the development and distribution of a firearm safety packet in partnership with firearm advocacy groups, licensed firearm dealers, local behavioral healthcare and health providers, among other partners.  
Increased public access to methods for safe storage of firearms will be accomplished by the procurement and distribution of cable style gun locks and the redeemable
