Enactment of this legislation will increase actuarially determined contribution rates for URS systems by between 0.05% and 2.5% depending on the retirement system. The fiscal impact represents the increased cost to the retirement systems for changes in retirement behavior identified by the actuary. Preliminary FY 2016 contribution rates for most URS systems exceed the actuarially determined contribution rate by more than the increase required by this bill. While enactment of this legislation may not increase URS retirement contribution rates, it will decrease funding of the unfunded actuarial accrued liability by state and higher education by approximately \$4.5 million annually. The requirement for employers of certain rehired retirees to pay the normal retirement costs in addition to the unfunded actuarial accrued liability (UAAL) costs could increase state and higher education costs by \$2.3 million annually, depending on how many eligible retirees are rehired.

Enactment of this legislation will increase actuarially determined contribution rates for URS systems by between 0.05% and 2.5% depending on the retirement system. The fiscal impact represents the increased cost to the retirement systems for changes in retirement behavior identified by the actuary. Preliminary FY 2016 contribution rates for most URS systems exceed the actuarially determined contribution rate by more than the increase required by this bill. While enactment of this legislation may not increase URS retirement contribution rates, it will decrease funding of the unfunded actuarial accrued liability by local governments and school districts by approximately \$15.5 million annually. The requirement for employers of certain rehired retirees to pay the normal retirement costs in addition to the unfunded actuarial accrued liability (UAAL) costs could increase employer costs by \$7.7 million annually, depending on how many eligible retirees are rehired.
