Enactment of this legislation could result in the Labor Commission losing its status as a Section 706 agency with the Equal Employment Opportunity Commission (EEOC) and as a substantially equivalent agency with the Department of Housing and Urban Development (HUD). This could result in an annual loss of \$550,500 in federal funding beginning in FY 2016. Enactment of this bill could result in an additional 25 court cases filed annually which would increase court filing fee revenue to the General Fund by approximately \$5,000 ongoing beginning in FY 2016.

Without federal funding to investigate claims of housing and employment discrimination through cooperative agreements with the EEOC and HUD, federal fund expenditures for the Labor Commission could be reduced by approximately \$550,500 annually beginning in FY 2016. The bill could also cost the Courts \$11,100 ongoing from the General Fund beginning in FY 2016 to handle an additional 25 cases annually. This bill removes certain claims from the protections of Governmental Immunity and imposes a higher burden of proof. To the extent that these changes allow new claims against the state, the state may incur additional defense, settlement, or judgment costs.
