2015 General Session Search and Rescue Financial Assistance Amendments - As Amended by DiCaro, S.

State Government UCA 36-12-13(2)(b)

Enactment of this legislation establishes the Utah Search and Rescue Assistance Card Program and allows the Division of Emergency Management in consultation with the Outdoor Recreation Office to establish a fee for the card. For each dollar of fee above an assumed \$2.50 per card minimum, the State could collect \$8,000 in dedicated credits annually. The actual fee amount will be set by the Division of Emergency Management and the Outdoor Recreation Office. Certain individuals would be eligible to purchase the card at a discounted price, and this could decrease the amount collected in dedicated credits.

Enactment of this legislation could cost the Department of Public Safety \$8,000 in dedicated credits annually for each dollar of fee above a \$2.50 per card minimum for the Search and Rescue Financial Assistance Program. Certain individuals would be eligible to purchase the card at a discounted price, and this could decrease collection and expenditure of dedicated credits. Programming and financial transactions likely will be provided by a private vendor at an assumed minimum rate of \$2.50 per search and rescue card sold. The Division of Emergency Management in consultation with the Outdoor Recreation Office will establish the actual fee amount.

Counties could be eligible for reimbursable expenses associated with search and rescue operations from the new Search and Rescue Financial Assistance Program established in this bill. Enactment of this legislation would allow counties to bill reimbursable expenses to an individual for costs incurred for the search and rescue of that individual under certain conditions.

Individuals & Businesses

UCA 36-12-13(2)(d)

Assuming 8,000 individuals purchase the card each year and the fee were set at \$3.50 per card, the total cost to individuals would be \$28,000 annually. Certain individuals would be eligible to purchase the card at a discounted price, and this could decrease the total cost. Enactment of this legislation would allow counties to bill reimbursable expenses to an individual for costs incurred for the search and rescue of that individual under certain conditions.

Notes on Notes

Fiscal notes estimate the direct costs or revenues of enacting a bill. The Legislature uses them to balance the budget. They do not measure a bill's benefits or non-fiscal impacts like opportunity costs, wait times, or inconvenience. A fiscal note is not an appropriation. The Legislature decides appropriations separately.
