Enacting this bill could increase federal funds receipts by the following amounts: \$0.6 million in FY 2015, \$83.2 million in FY 2016, and \$82.1 million in FY 2017.

This bill appropriates the estimated costs to Medicaid of \$143,000 one-time General Fund and \$578,000 federal funds in FY 2015, \$31,956,200 ongoing General Fund, \$115,200 one-time General Fund, and \$83,150,800 federal funds in FY 2016. This bill provides nonlapsing authority for all appropriations provided. The bill appropriates the estimated costs to Medicaid, which include administrative costs, services to newly eligible clients, and more currently eligible, but not enrolled Medicaid clients signing up for Medicaid. These appropriations go to four agencies: Department of Health, Department of Human Services, Department of Workforce Services, and the Utah Department of Corrections.

# Local Government

UCA 36-12-13(2)(c)

Local government mental health and substance abuse services will be replaced with Medicaid coverage for 18,000 individuals which generates General Fund savings of about \$200,000 in FY 2016. County governments will also see savings for newly eligible inmates for Medicaid to cover some inpatient hospital medical costs.

### Individuals & Businesses

Up to 35,000 recipients could begin paying existing Medicaid co-pays and other related costs beginning in FY 2016 in exchange for expanded services.
