Local Government UCA 36-12-13(2)(c)

Enactment of this bill requires a participating municipality to charge a disproportionate rental fee reduction if a residential landlord owns multiple properties that are in compliance with their respective city. Local government may receive less revenue due to the fee reduction, the amount will vary based on voluntary participation from cities.

UCA 36-12-13(2)(d)

Residential landlords that are in compliance may receive a fee reduction for their rental properties.
