Purpose: 1.) Build administrative support with high expectations of American Indian/Alaskan Native students, 2.) strengthen Tribal support to develop and enhance of curriculum to include historical and culturally accurate, sensitive and fosters the protection of h

Services: 1.) Provide a five-year pilot program to address the educational needs of the American Indian/Alaskan Native students, 2.) create a pilot program to fund salary, recruitment and retention of teachers that teach in American Indian/Alaskan Native high concentrated schools, 3.) create a pilot program for regional service centers to fund individuals facilitating Title VII, Elementary and Secondary Education Act.

Expected Outcome: 1.) American Indian/Alaskan Native students meet the high expectations, 2.) close the achievement gap, 3.) develop a state plan that consists of addressing and improving the education of the American Indian/Alaskan Native students, 4.) build a foundation toward college and career ready programs.

Implementations and Resources: The finances will be set up in a competitive grant funding format in each regional service center where the board will distribute to those who qualify for the grant. The target population are those school districts who have a high concentrated schools with American Indian/Alaskan Native students. The service center providers will collect data, provide updated materials, books, supplies and collaborate with the local tribe, schools, school districts, community and the State Office of Education.

How: The focus will be on the American Indian/Alaskan Native students to generate the excitement, enthusiasm, willingness and to become goal orientated to achieve there educational dreams.

Description: The students will be more aware of the importance of test preparation and test taking to improve their state test scores.
