Enactment of this bill could reduce the Education Fund by \$60,000 in FY 2018 and by \$75,000 in FY 2019 as the tax credits authorized in the bill are claimed.

Enactment of this legislation could cost the Governor's Office of Economic Development one-third of an existing FTE, redirecting \$36,700 in General Fund effort to administer the provisions of the bill. The agency has indicated it can absorb the costs within current resources.

Enactment of this legislation likely will not result in direct, measurable costs for local governments.

UCA 36-12-13(2)(d)

Enactment of this bill could result in a tax credit for certain contributions to a nonprofit corporation related to an approved project in an enterprise zone. The tax credit may be up to 50% of the contribution. The total amount of nonprofit contribution tax credits issued may not exceed \$75,000 in any fiscal year.
