UCA 36-12-13(2)(b)

Enactment of this legislation could increase revenues to the new Utah Intracurricular Student Organization Support for Agricultural Education and Leadership Restricted Account in the amount of \$12,500 annually beginning in Fiscal Year 2018 from a \$25 annual fee for special group license plates from approximately 500 Utah residents. If license plate production costs are covered by private donations, the Tax Commission could receive \$7,500 in dedicated credits revenue, assuming 500 three-color plates are ordered.

Enactment of this legislation could cost the Department of Administrative Services \$1,000 one-time in Fiscal Year 2018 and \$500 ongoing from the General Fund beginning in FY 2018 for costs to create and manage the new fund created in this legislation. The Department of Administrative Services has indicated it can absorb this cost in its existing budget. Enactment of this legislation could cost the Tax Commission \$7,500 in dedicated credits expenditures for license plate production startup costs.

Local Government

UCA 36-12-13(2)(c)

Enactment of this legislation likely will not result in direct, measurable costs for local governments.

Enactment of this legislation could support the availability of additional funds for certain organizations, for a total of \$12,500 annually if 500 plates are ordered. Individuals choosing to purchase these special license plates would spend \$25 annually at the time of registration, in addition to the applicable license plate fees.
