If every eligible business chose to participate, enactment of this legislation could reduce revenue to the Education Fund by \$1.5 million in FY 2019. Assuming ten percent of all eligible businesses claim the credit, revenue may decrease by \$149,000 one-time in FY 2019.

## **Notes on Notes**
