Enactment of this bill could result in \$45,000 ongoing in fee revenue for the Lieutenant Governor"s Office beginning in FY 2019 from fines for not completing harassment training by set deadlines and \$750 ongoing revenue beginning in FY 2019 for the Department of Human Resource Management from contracting with the Lieutenant Governor"s Office to assist in harassment investigations. Enactment of this bill could also result in an unknown revenue amount beginning in FY 2019 to the Lieutenant Governor"s Office for each additional lobbyist found to have conducted unlawful harassment and fined \$2,000.

Enactment of this bill could cost the Lieutenant Governor"s Office \$250 one-time in FY 2019 for developing unlawful harassment training for lobbyists, \$750 ongoing beginning in FY 2019 to contract with the Department of Human Resource Management to assist in unlawful harassment investigations, and \$1,500 one-time in FY 2019 to write and develop administrative rules for unlawful harassment. Enactment of this bill could also cost the Department of Human Resource Management \$2,700 to write and develop administrative rules for unlawful harassment and \$750 ongoing to conduct unlawful harassment investigations. The Lieutenant Governor"s Office and the Department of Human Resource Management have indicated they can absorb the costs in their existing budgets.

Enactment of this bill could cost Lobbyists \$45,000 ongoing beginning in FY 2019 from fines for not completing harassment training by set deadlines. Enactment of this bill could also result in an unknown cost beginning in FY 2019 for each additional lobbyist found to have conducted unlawful harassment and fined \$2,000.
