Public Benefit:

Purpose: The purposes of the new Oversight Committee are to increase transparency, efficiency, effectiveness, and accountability of state governmental entities and local governmental entities.

Services: - Investigating waste, fraud, misconduct, or abuse. - Investigating accounting, expenditure, and handling of funds. - Studying an entity's application of law. - Investigating an entity's compliance with law. - Investigating an entity's administrative rules. - Investigating whether an entity's actions are in accordance with best practices. - Drafting and reviewing concurrent resolutions containing administrative rules.

Expected Outcome: Improved state and local government effectiveness through increased legislative oversight of state and local government spending, application of laws, administrative rules, and practices.

Implementations and Resources: This bill will be implemented by the new Oversight Committee, consisting of 3 Senators and 6 Representatives. The Office of Legislative Research and General Counsel and the Office of the Legislator Auditor General will jointly staff the committee. Any additional resources for investigations and studies will depend on the workload taken on by the committee, but could include additional work by legislative staff and consultants.

How: Through investigations, audits, or studies, the Oversight Committee will increase legislative review of state and local governmental entities' spending, compliance with laws, drafting of administrative rules, and practices.
