State Government UCA 36-12-13(2)(b)

Enactment of this bill could increase ongoing fine/fee revenue to the following funds or accounts beginning in FY 2019: (1) General Fund - \$146,800; and (2) General Fund Restricted - DNA Specimen Account - \$31,500.

Enactment of this bill could have a total cost from the General Fund of \$517,500 in FY 2019 and \$587,700 in FY 2020 and increase each year thereafter until FY 2023 when costs reach a steady state of \$798,300. The General Fund cost breakdown is as follows: (1) Corrections - \$104,100 in FY 2019 and \$173,500 in FY 2020 for incarceration costs and increase to \$381,700 by FY 2023; (2) Board of Pardons - \$1,200 in FY 2019 and FY \$2,000 in FY 2020 and increase to \$7,400 by FY 2023; (3) Courts - \$359,600 ongoing beginning in FY 2019 for additional processing costs; and (4) Department of Public Safety - \$52,600 ongoing beginning in FY 2019 for DNA processing. In addition this could cost the Department of Public Safety about \$20,500 ongoing from the General Fund Restricted - DNA Specimen Account for processing.

Local Government UCA 36-12-13(2)(c)

Enactment of this bill could shift about 955 cases from local justice courts to state courts resulting in about \$359,600 in ongoing reduced costs beginning in FY 2019. This change including other provisions in the bill could shift ongoing fine revenue of \$146,800 to the state General Fund in FY 2019. For each additional commitment to county jails as a result of the bill, incarceration costs are approximately \$70 per day.

#### Individuals & Businesses

UCA 36-12-13(2)(d)

Enactment of this bill could cost 840 individuals about \$37.50 each in fines/fees for a total of \$31,500 ongoing beginning in FY 2019.

## Regulatory Impact

UCA 36-12-13(2)(e)

Enactment of this legislation could result in a small increase in the regulatory burden for Utah residents or businesses.
