Enactment of this bill could cost the Department of Human Services (1) \$2,595,000 from the General Fund on-going beginning in FY 2019 for the development of five new Mobile Crisis Outreach Teams, and (2) \$250,000 one-time in FY 2019 for grants devoted to mental health crisis response trainings. This \$250,000 one-time General Fund is appropriated in the bill. Enactment of this legislation could cost the State Board of Education (1) \$275,000 for suicide prevention trainings in secondary schools statewide and (2) \$500,000 for grants to each institution of higher education for development of a School Safety and Crisis Line (lines 194-195). Both of these would be ongoing appropriations from the Education Fund, beginning in FY 2019.

## Local Government

UCA 36-12-13(2)(c)

Enactment of this legislation may cost local education agencies a total of \$275,000 (approximately \$633 per school) for youth suicide prevention programs in secondary schools. Additionally, counties may receive some of the grant funding for mobile crisis outreach team expansion and mental health crisis response training.

UCA 36-12-13(2)(d)

Enactment of this legislation will allow optional contributions to the Governor's Suicide Prevention Fund through individual income tax returns. Based on precedent of contributions to similar funds, an estimated 775 people will contribute \$19 for a total of \$14,700 annual revenue to the Governor's Suicide Prevention Fund.

Regulatory Impact

UCA 36-12-13(2)(e)

Enactment of this legislation likely will not change the regulatory burden for Utah residents or businesses.

## **Notes on Notes**
