UCA 36-12-13(2)(b)

Enactment of this legislation may decrease \$13,300 in General Fund revenue to the Department of Health, ongoing beginning in FY19, from lost birth certificate fee revenue. Enactment of this legislation may decrease \$2,300 to the Children's Account in the Department of Human Services, ongoing beginning in FY19, from lost birth certificate fee revenue. Enactment of this legislation may decrease \$28,500 to the Department of Public Safety Restricted Account in the Department of Public Safety, ongoing beginning in FY 19, from lost identification card fee revenue.

Enactment of this legislation could cost the Department of Public Safety \$7,900 one-time in FY18 from the General Fund for programming costs to update the system to allow driver's license fee waivers. Enactment of this legislation could cost the Department of Workforce Services \$5,000 ongoing beginning in FY19 from the General Fund to provide verification services to homeless individuals. It could also save the Department \$200 ongoing beginning in FY19 from the General Fund from no longer paying these fees for homeless individuals.

Local Government

UCA 36-12-13(2)(c)

Local Health Departments (LHDs) which sell birth certificates may see a decrease in revenue from waived birth certificate fees. There is not sufficient data to determine specific impact.

Individuals & Businesses

UCA 36-12-13(2)(d)

Homeless individuals may see cost savings of \$20 (fee for a birth certificate) and \$18 (fee for an identification card), with a total savings of \$38 per individual, if both documents are purchased. Nonprofit providers who, in some cases, pay these fees for homeless individuals may see a cost savings as well. It is estimated that 780 individuals will seek the fee waiver for birth certificates, and 1690 individuals will seek the fee waiver for identification cards, for a total cost savings of \$44,100 to the homeless population.

Regulatory Impact

Enactment of this legislation likely will not change the regulatory burden for Utah residents or businesses.

Notes on Notes

Fiscal notes estimate the direct costs or revenues of enacting a bill. The Legislature uses them to balance the budget. They do not measure a bill's benefits or non-fiscal impacts like opportunity costs, wait times, or inconvenience. A fiscal note is not an appropriation. The Legislature decides appropriations separately.
