Local Government UCA 36-12-13(2)(c)

Enactment of this bill could result in an estimated \$9,300 increase in revenue for municipalities and counties every two-year election cycle from requiring filing fees from write-in candidates.

## Individuals & Businesses

UCA 36-12-13(2)(d)

Enactment of this bill could cost write-in candidates an estimated \$9,300 every two-year election cycle from individual fees ranging from between \$100 and \$1,400.
