This legislation appropriates \$40,000 ongoing from the General Fund beginning in FY 2020 to a new restricted account, the Survivors of Suicide Loss Account. It also appropriates \$275,000 ongoing from the General Fund beginning in FY 2020 to another new restricted account, the Psychiatric Consultation Program Account. Enactment of this legislation could reduce the year-end transfer from the Commerce Service Fund to the General Fund by \$2,500 one-time in FY 2019; however, the Division of Occupational and Professional Licensing has indicated it can absorb these costs in its existing budget, such that there would be no impact to the General Fund.

This legislation appropriates the following amounts ongoing beginning in FY 2020 to the Division of Substance Abuse and Mental Health: 1) \$40,000 from the Survivors of Suicide Loss Account for grants to survivors for therapy, clean-up, and bereavement services; 2) \$275,000 from the Psychiatric Consultation Program Account for grants to healthcare facilities to create telehealth consultation programs; and 3) \$285,000 from the General Fund for various suicide prevention efforts. It further appropriates \$700,000 one-time from the General Fund in FY 2020 to the Governor's Office to be used for the same purposes as funds collected into the Governor's Suicide Prevention Fund; the amount granted out is not to exceed the amount collected into the fund after October 31, 2018. Enactment of this legislation could cost the Division of Occupational and Professional Licensing \$2,500 one-time from the Commerce Service Fund in FY 2019 to write rules and post suicide

prevention education videos for healthcare practitioners to view as a condition of license renewal; the division has indicated it can absorb these costs in its existing budget.
