S.B. 106 1st Sub. (Green)

Local Government UCA 36-12-13(2)(c)

Enactment of this bill may increase ongoing revenues received from medical billings to local education agencies or local mental health authorities by \$142,000 beginning in FY 2020 from the following three sources: (1) \$90,000 from commercial insurance plans, (2) \$16,000 from PEHP, and (3) \$36,000 from Medicaid if those local agencies pay the required match of \$11,200. Enactment of this legislation could also increase the cost of health insurance for local governments by \$1,000 beginning in FY 2020.

Individuals & Businesses

UCA 36-12-13(2)(d)

Individuals and businesses may see an increase in insurance coverage costs of around \$90,000 beginning in FY 2020.

Regulatory Impact

UCA 36-12-13(2)(e)

Enactment of this legislation could result in a small increase in the regulatory burden for Utah residents or businesses.
