Purpose: To create a scholarship for individuals to enroll in career and technical education programs at USU Eastern, Snow College, and Salt Lake Community College.

Services: Additional scholarships for select students.

Expected Outcome: 1. New Administrative Rule established by the Board of Regents regarding funding distribution, program administration requirements, eligibility requirements, application process, and how institutions should determine satisfactory progress. 2. The Board of Regents and the state's Department of Workforce Services will develop a list of approved high demand, non-credit CTE programs that would be eligible for consideration. 3. Non-credit CTE scholarship opportunities at USU Eastern & Moab, Snow College, Salt Lake Community College.

Implementations and Resources: The Scholarship program will be ready for students to participate for Fall 2020 enrollment. Primary Resources Needed: Staff time to coordinate meetings with the impacted institutions, develop the proposed formula, application process, eligibility, administration guidelines, prioritization process, and list of acceptable programs. Long-term, institutions may need additional financial aid staff to help administer the scholarship program.

How: Increased financial aid opportunities for non-credit career and technical education programs. Increased awareness of non-credit CTE programs offered by USHE institutions and how well they may be aligned to the workforce needs in these areas.

o Number of applications and awards for this scholarship  
o How many students qualified for but did not receive the award  
o The programs that students are enrolled in that received the award  
o The average award received by students  
o Progress and completion rate for students receiving the scholarship
