This bill deposits \$10,710,500 in FY 2021 into the unrestricted General and Education Funds. It transfers another \$247,659,900 in FY 2021 from the General/Education Funds into other funds and accounts. This bill reduces General Fund deposits by \$4,697,700 in FY 2021 by appropriating from funds and accounts that impact year-end transfers to the General Fund.

This bill appropriates \$1,084,525,800, including \$195,369,600 from the General/Education Funds for FY 2021. These appropriations support the operations and capital acquisitions of state government, including expendable funds and accounts. It transfers another \$247,659,900 in FY 2021 from the

General/Education Funds into other funds and accounts. This bill appropriates another \$4,697,700 in FY 2021 from funds and accounts that impact General Fund revenue.
