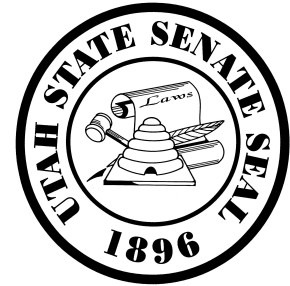

Enactment of this legislation prohibits the issuance of a license, permit, or tag related to fishing or hunting if an individual is delinquent in child support, which could reduce the revenues to the Division of Wildlife Resources. We assume that two-thirds of the 6,030 individuals who have purchased license or permit for fishing or hunting and are currently delinquent on their child support, would not be allowed to purchase the Combination Hunting/Fishing Licenses (\$38 each) and the Draw Applications to hunt big game (\$10 each) for a while. This would result in a reduced revenue to the Wildlife Resources Restricted Account of \$193,000 and reduced matching Federal Funds of \$246,900, totaling \$439,900 revenue loss per year.

Enactment of this legislation could cost the Division of Wildlife Resources \$83,000 one-time and \$24,000 ongoing from the General Fund, starting in FY 2021. The bill could also cost the Office of Recover Services one-time in FY 2021 as follows: \$58,600 in Federal Funds, and \$30,200 from the General Fund, which they indicated that they could cover with existing appropriations.

Local Government

UCA 36-12-13(2)(c)

Enactment of this legislation likely will not result in direct, measurable costs for local governments.

Individuals & Businesses

UCA 36-12-13(2)(d)

Enactment of this legislation would prevent an individual delinquent in child support from purchasing a license, permit, or tag related to fishing or hunting. An estimated 4,020 individuals would not pay \$48 in permit fees.

Regulatory Impact

UCA 36-12-13(2)(e)

Enactment of this legislation could result in a small increase in the regulatory burden for Utah residents or businesses.

Notes on Notes

Fiscal notes estimate the direct costs or revenues of enacting a bill. The Legislature uses them to balance the budget. They do not measure a bill's benefits or non-fiscal impacts like opportunity costs, wait times, or inconvenience. A fiscal note is not an appropriation. The Legislature decides appropriations separately.
