Enactment of the bill could increase state sales and use taxes by an estimated \$1.53 million in FY 2021 and \$3.66 million in FY 2022. This bill appropriates \$1.53 million in FY 2021 and \$3.66 million from the General Fund ongoing to the Railroad Transportation Restricted Account created in the legislation.

This bill appropriates \$1.53 million in FY 2021 and \$3.66 million ongoing from the General Fund to the Railroad Transportation Restricted Account beginning in FY 2022. The bill could also cost the Department of Transportation up to \$1.53 million in FY 2021 and \$3.66 million ongoing in FY 2022 from the restricted fund for projects that meet the criteria of the legislation.
