Enactment of this legislation could cost some mosquito abatement districts approximately \$900 in one-time costs and \$150 in ongoing costs for the development and maintenance of websites; the aggregate impact would be approximately \$6,300 in one-time costs and \$1,100 in ongoing costs. Enactment of this legislation could also increase administrative costs for some mosquito abatement districts; the impact cannot be quantified at this time.
