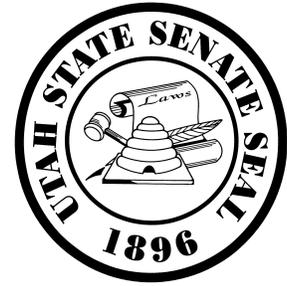

To the extent that new public infrastructure districts levy new property taxes or otherwise generate revenue, enactment of this legislation could result in increased tax or fee burdens on businesses and individuals within their boundaries.
