Enactment of this legislation could increase ongoing fine/fee revenue to the following accounts beginning in FY 2021: (1) General Fund - \$3,000; (2) Criminal Surcharge - \$5,400; and (3) Court Security - \$400.

Enactment of this bill could have a net cost of \$20,000 one-time in FY 2020 and \$174,800 ongoing from the General Fund beginning in FY 2021. This assumes a total of about 2 new prisoners each year committed for 12 months. The ongoing cost breakdown is as follows beginning in FY 2021: (1) Courts - \$103,600 for case process/protective order hearings and \$20,000 one-time for programming changes in FY 2020; (2) Department of Corrections - \$70,000 for incarceration; and (3) Board of Pardons and Parole - \$1,200 for additional hearings.

Local Government UCA 36-12-13(2)(c)

Enactment of this bill could increase ongoing local fine revenue of \$3,000 beginning in FY 2021. The bill could also have the following ongoing statewide costs: (1) \$16,000 for incarceration costs; (2) about \$25,000 to local police departments for police officer court appearances; (3) Unknown costs to local law enforcement to serve more protective orders, but the Sheriff's Association submits that these may be absorbed within current budget levels; and (4) Unknown costs for additional storage in police department evidence and storage facilities.

Individuals & Businesses

UCA 36-12-13(2)(c)

Individuals cited for violations could pay an aggregated \$6,400 in fines and an additional \$5,400 to the Criminal Surcharge Account.

Regulatory Impact

UCA 36-12-13(2)(d)

Enactment of this legislation could result in a small increase in the regulatory burden for Utah residents or businesses.
