Local Government

UCA 36-12-13(2)(c)

Enactment of this legislation could increase the costs to counties and cities for workers" compensation cases related to COVID-19 by at least \$1,431,300 one-time in FY 2021 for non-medical first responders. These increased costs would come from an expected two weeks of compensation related to lost time away from employment for an expected 5% of local/county non-medical first responders. Significant additional costs could be incurred depending upon whether the definition of "first responder" is deemed to include local health department employees and other personnel, including volunteers, who support efforts to combat COVID-19.

H.B. 3007 1st Sub. (Buff)

Individuals & Businesses

Enactment of this legislation could increase Worker's Compensation rates for employers of certain first responders, including those in the medical field and possibly those that support front-line medical staff, including volunteers. We are unable to estimate the cost associated with these rate increases at this time.

Regulatory Impact

UCA 36-12-13(2)(d)

Enactment of this legislation could result in a small increase in the regulatory burden for Utah residents or businesses.
