UCA 36-12-13(2)(c)

To the extent that more people are convicted of a Class B misdemeanor instead of a 3rd-degree felony as a result of this bill, this could decrease revenue/case in the following amounts: (1) General Fund \$1,150; (2) Court Security \$15. To the extent that bail forfeitures decrease as a result of this legislation, enactment of this bill could reduce a maximum revenue of \$3,000 to the Pre-trial Release Programs Special Revenue Fund and \$1,250 to the General Fund per offender.

To the extent that a case is filed in justice court instead of district court as a result of this bill, enactment of this legislation could save the Courts \$790 from the General Fund per case. To the extent that fewer offenders are sentenced to prison or probation, it could save the Department of Corrections \$85/bed/day and \$12/day for supervision. It could also save the Board of Pardons and Parole \$390 per hearing.

Local Government

UCA 36-12-13(2)(c)

To the extent that more people are convicted of a Class B misdemeanor instead of a 3rd-degree felony, enactment of this bill could increase revenue to local governments by about \$350/case for fines/fees. This bill could also cost justice courts an unknown amount in court processing costs and county jails about \$83/day/offender in incarceration costs. To the extent that bail forfeitures decrease as a result of this legislation, enactment of this bill could reduce a maximum revenue of \$750 to the local prosecuting office per offender. To the extent that incarceration times are lengthened as a result of this legislation, counties could see increased costs of \$83/day/offender to house individuals who are held without bail.

Individuals & Businesses

UCA 36-12-13(2)(c)

To the extent that more people are convicted of a Class B misdemeanor instead of a 3rd-degree felony as a result of this bill, this could save certain offenders about \$820/case, however the total amount is unknown.

Regulatory Impact

UCA 36-12-13(2)(d)

Enactment of this legislation likely will not change the regulatory burden for Utah residents or businesses.

Notes on Notes

Fiscal notes estimate the direct costs or revenues of enacting a bill. The Legislature uses them to balance the budget. They do not measure a bill's benefits or non-fiscal impacts like opportunity costs, wait times, or inconvenience. A fiscal note is not an appropriation. The Legislature decides appropriations separately.
