Enactment of this bill could result in ongoing General Fund revenue, beginning in FY 2022 of \$5,200 from the assessment of fines and the Criminal Surcharge. This could also result in \$200 in ongoing revenue to the Court Security Account beginning in FY 2022.

Enactment of this bill could cost a total of \$47,000 from the General Fund in FY 2022, \$89,300 in FY 2023, \$122,000 in FY 2024, and \$155,700 each year thereafter. This assumes a total of about 3 new individuals sentenced to probation and 1 new prisoner each year until released in FY 2025 when the total increased prisoner/probationer count reaches a constant state of 10 additional prisoners/ probationers and presumes an average prison length of stay of 4 years and probation for up to 2 years. The cost breakdown is as follows: 1. Courts - \$4,700 ongoing beginning in FY 2022 for case processing; 2. Department of Corrections - \$39,500 in FY 2022, \$79,000 in FY 2023, \$111,000 in FY 2024 and \$144,000 each year thereafter for incarceration and supervision costs; and, 3. Board of Pardons and Parole - \$2,800 in FY 2022, \$5,600 in FY 2023, \$6,300 in FY 2024 and \$7,000 each year thereafter for additional hearings.

Enactment of this bill could result in a fiscal impact for local entities which could see fine revenue increase by an estimated \$2,700. It could also cost local prosecutors an estimated \$6,600 to prosecute the additional violations of provisions of this bill.

The Legislature decides appropriations separately.
