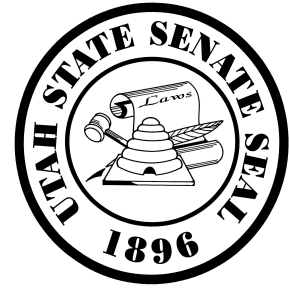

The bill appropriates \$500,000 one-time from the General Fund in FY 2022 to the Peace Officer Training Enhancement Restricted Account created by this legislation.

The bill appropriates \$500,000 one-time from the General Fund in FY 2022 to the Peace Officer Training Enhancement Restricted Account created by this legislation. Enactment of this legislation could lead the Department of Public Safety to award up to \$500,000 in grants from the account to law enforcement entities for personnel to participate in an approved outward mindset and equality training program. Enactment could cost the Department of Administrative Services \$700 one-time from the General Fund in FY 2022 to set up the restricted account (the agency can absorb the cost).

**Notes on Notes**
