Enactment of this legislation may reduce ongoing dedicated credits for the Department of Public Safety by (\$30,000) beginning in FY 2022 due to 1,300 individuals (1) no longer paying \$33.25 for a duplicative federal background check and (2) paying a \$10 cloning fee to send their background check information to a second agency.

Enactment of this legislation may cost the State \$43,900 (\$29,200 General Fund and \$12,500 Education Fund), \$1,100 from federal funds, and \$1,000 from Transfers, one-time in FY 2021 for programming costs across three state agencies to share state background check information between agencies, and a reduction of (\$30,000) ongoing from dedicated credits beginning in FY 2022 for the Department of Public Safety from processing 1,300 fewer federal background checks and 1,300 more clonings of existing federal background check information to share with another state agency.

Local Government

UCA 36-12-13(2)(c)

Local government entities paying federal background checks for their employees or volunteers working in programs licensed by Human Services, Utah State Board of Education, or the Department of Health may pay \$22.25 less per person who works in two or more programs that are licensed by different state agencies.

Individuals & Businesses

UCA 36-12-13(2)(c)

Individuals who are employees or volunteers working in programs licensed by Human Services, Utah State Board of Education, or the Department of Health or their employers may pay \$22.25 less per person who works in two or more programs that are licensed by different state agencies.

Regulatory Impact

UCA 36-12-13(2)(d)

Enactment of this legislation likely will not change the regulatory burden for Utah residents or businesses.
