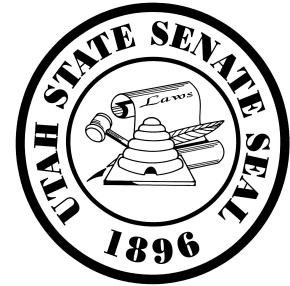

Enactment of this bill appropriates \$1,752,200 ongoing from the General Fund to the Paid Postpartum Recovery and Parental Leave Program. The bill may cost the Division of Finance \$6,500 one-time in FY 2022 and \$4,000 ongoing beginning in FY 2023 for system programming and financial accounting.
