Counties that receive grants to develop Assertive Community Treatment (ACT) teams could use those funds to draw down additional federal funds, depending on the number of clients who are Medicaid eligible.

Enactment of this legislation could cost the Department of Health and Human Services \$1 million one-time from the General Fund, likely spent over FY 2024 and FY 2025, to administer and disburse grants for counties to develop ACT teams. The legislation appropriates that same amount, which would be nonlapsing through FY 2025.

Counties could apply for and receive grants up to approximately \$959,600 in aggregate to develop ACT teams and could use those funds to draw down additional federal funds, depending on the number of clients who are Medicaid eligible.

Enactment of this legislation likely will not result in direct expenditures from tax or fee changes for Utah residents and businesses.
