Enactment of this legislation may cost the State \$8,900 General Fund, \$30,000 Medicaid Expansion Fund, \$600,000 expendable receipts, and \$1,526,300 federal funds in FY 2024 as well as ongoing \$1,400 General Fund, \$60,000 Medicaid Expansion Fund, \$1,200,000 expendable receipts, and \$2,913,800 federal funds in FY 2025 to reimburse recreational therapy as a covered service in Medicaid.

Local Government UCA 36-12-13(2)(c)

Enactment of this legislation may cost mental health local authorities \$600,000 in FY 2024 and \$1,200,000 ongoing in FY 2025. These local authorities would receive \$1,800,000 in FY 2024 and \$3,600,000 ongoing in FY 2025 to reimburse recreational therapy as a covered service in Medicaid.
