Beginning in FY 2024, for any portion of the annual surplus deposited into the State Disaster Recovery Restricted Account (as part of any surplus processing at the end of each fiscal year), this bill will transfer 25% of this amount into the repurposed/renamed Local Response, Recovery, and Post-Disaster Mitigation Restricted Account. Any amount over \$50,000,000 in the new account would be transferred back to the State Disaster Recovery Restricted Account. Had this provision been in effect at the end of FY 2022, it would have resulted in \$7.1 million going into the Local Response, Recovery, and Post-Disaster Mitigation Restricted Account instead of the State Disaster Recovery Restricted Account Account for the Local Response, Recovery, and Post-Disaster Mitigation Restricted Account instead of the State Disaster Recovery Restricted Account.
