Enactment of the sales tax exemption for sand, gravel rock aggregate, or cement products between entities that are related through 100% common ownership or control is estimated to reduce state tax revenues to the General Fund and earmarks by approximately \$2.4 million in FY2024 and \$2.7 million in FY2025.

Additionally, enactment of the rolling stock sales tax exemption could result in forgone future sales tax revenue; the aggregate impact is unknown.

Local Government UCA 36-12-13(2)(c)

Enactment of the sales tax exemption for sand, gravel rock aggregate, or cement products between entitles that are related through 100% common ownership or control is estimated to reduce local tax revenues by approximately \$1.2 million in FY2024 and \$1.3 million in FY2025.

Additionally, enactment of the rolling stock sales tax exemption could result in forgone future local sales tax revenue; the aggregate impact is unknown.

UCA 36-12-13(2)(c)

Enactment of the sales tax exemption for sand, gravel rock aggregate, or cement products between entitles that are related through 100% common ownership or control is estimated to reduce sales tax liability for these taxpayers by approximately \$3.6 million in FY2024 and \$4.0 million in FY2025.

Regulatory Impact UCA 36-12-13(2)(d)

Enactment of this legislation likely will not change the regulatory burden for Utah residents or businesses.

This bill does not create a new program or significantly expand an existing program.
