Enactment of this legislation appropriates \$170,000,000 from the General Fund and \$30,000,000 from the American Rescue Plan Act to the Agricultural Water Optimization Account for irrigation efficiency grants. Enactment of this legislation also appropriates \$50,000,000 ongoing from the Water Infrastructure Restricted Account to the Water Resources Conservation and Development Fund for a loan to Washington County for various projects as outlined in intent and a grant for construction on the Hyrum Reservoir.

Enactment of this legislation transfers \$170,000,000 from the General Fund and \$30,000,000 from the American Rescue Plan Act one-time in FY 2024 to the Agricultural Water Optimization Account. This legislation also appropriates \$125,000,000 from the Agricultural Water Optimization Account to the Division of Resource Conservation for grants to improve water efficiency of agriculture water users through various technologies as outlined in the bill. Finally, enactment of this legislation appropriates \$50,000,000 from the Water Infrastructure Restricted Account to the Water Resources Conservation and Development Fund ongoing beginning in FY 2024 for a loan to be used in the Colorado River drainage in Utah and a grant for construction on the Hyrum Reservoir.
