Local Government

UCA 36-12-13(2)(c)

Enactment of this bill could decrease the funded ratio for the Tier I Firefighters Division B System by 0.1%, bringing it to 109.4%. That change could increase the local government employer contribution rate by 0.1% costing participating local government employers combined up to \$80,000 per year ongoing beginning in FY 2024.

Individuals & Businesses

UCA 36-12-13(2)(c)

Surviving spouses of Division B firefighters with more than 20 years of service who pass in non-line of duty circumstances could receive retirement benefits similar to what would have been paid to the employee upon retirement.

Regulatory Impact

UCA 36-12-13(2)(d)

Enactment of this legislation likely will not change the regulatory burden for Utah residents or businesses.
