Enactment of this legislation could increase dedicated credits revenue for the Division of Technology Services by \$26,00 one-time in FY 2025 billed to the Governor's Office for programming costs associated with making financial disclosures available for public searching.

Enactment of this legislation could cost the Governor's Office \$26,000 one-time in FY 2025 from the General Fund to completed the needed technological needs of making financial disclosures available for public searching. Additionally, enactment of this legislation could cost the Division of Technology Services \$26,000 one-time from dedicated credits in FY 2025 for programming costs associated with making financial disclosures available for public searching. The Governor's Office must absorb the costs under the provisions of the bill.

To the extent that this bill requires local candidates' financial disclosures being available for public searching, enactment of this legislation could cost \$2,500 statewide.

Individuals & Businesses

Enactment of this legislation likely will not result in direct expenditures from tax or fee changes for Utah residents and businesses.

Regulatory Impact

Enactment of this legislation likely will not change the regulatory burden for Utah residents or businesses.
