Enactment of this legislation could generate revenue for the Courts of up to \$12,800 per year beginning in FY 2025 from criminal fines charged to individuals with \$12,500 of that being deposited in the General Fund and \$300 being deposited into the Court Security Account.

Enactment of this legislation could cost the Department of Corrections \$187,200 ongoing General Fund beginning in FY 2025, \$73,200 of which would be for supervising an additional 4 probation commitments per year and \$114,000 for housing an additional 1 prison commitment per year. This cost would be reduced one-time by \$124,800 in FY 2025 and \$62,400 in FY 2026 due to ramp up savings. Enactment of this Legislation could also cost the Board of Pardons and Parole \$2,300 ongoing General Fund beginning in FY 2025 for additional hearings of convicted persons. This cost would be reduced one-time by \$1,500 in FY 2025 and \$800 in FY 2026 due to ramp up savings. Enactment of this legislation could also cost the Courts \$3,500 ongoing General Fund beginning in FY 2025 to prosecute additional cases.

Local Government UCA 36-12-13(2)(c)

Enactment of this legislation could cost local prosecutors approximately \$7,500 per case to prosecute for this new offense for a total of cost of up to \$60,000 per year.

Individuals & Businesses

UCA 36-12-13(2)(c)

Enactment could cost individuals convicted of this crime up to \$2,500 per conviction in criminal fines for a total estimated cost of up to \$13,000.

Regulatory Impact UCA 36-12-13(2)(d)

Enactment of this legislation likely will not change the regulatory burden for Utah residents or businesses.

## Performance Evaluation

This bill does not create a new program or significantly expand an existing program.

## **Notes on Notes**
