### Local Government

Enactment of this legislation may result a change in how \$188.2 million ongoing appropriated by the state for the Class Size Reduction program is allocated among local education agencies. Changing distribution from K-8 enrollment to K-3 enrollment results in a decrease for some LEAs ranging from (\$215) to (\$901,500) and an increase for other LEAs ranging from \$460 to \$195,800. The amount will vary between these ranges depending on the enrollment characteristics of each local education agency.

### Individuals & Businesses

Enactment of this legislation likely will not result in direct expenditures from tax or fee changes for Utah residents and businesses.

## **Regulatory Impact**

Enactment of this legislation likely will not change the regulatory burden for Utah residents or businesses.
