Enactment of this legislation could reduce Income Tax Revenues by \$21.4 million in FY 2025 and an additional \$21.6 million in FY 2026, with reductions growing by approximately \$21 million each year thereafter. This would correspond with an increase of the same amounts in the Performance Funding Restricted Account within the Utah System of Higher Education.

Enactment of this legislation could increase expenditures from the Performance Funding Restricted Account within the Utah System of Higher Education by \$21.4 million in FY 2025 and an additional \$21.6 million in FY 2026, with approximately \$21 million in increased costs each year distributed to the 16 public institutions of higher education in the State as a result of meeting performance goals.
