Description:

Created in 1990 general session through passing of HB 230. All fees collected by each division and by the department are deposited in this fund. Excess fees at year end above appropriation shall be transferred to General Fund.

HB 135 (2007 GS) Provided DOPL with the authority to issue citations and impose fines to persons who violate the unlawful conduct provisions of the Utah Building Standards Act. Directed that the fines from such violations will be deposited in the Commerce Service Fund.

SB 236 (2007 GS) Bill establishes a new type of mark, called an electronic registration mark, which will be deposited in the Commerce Service Fund.

HB 63 (2008 GS) Modified Title 63, State Affairs in General, by recodifying and renumbering the content of the title to other parts of the code, which sections were referenced in the code section for this fund.

HB 297 (2009 GS) Recodified the Budgetary Procedures Act, which is cited in the section of code relating to this fund.

HB 391 (2009 GS) Removed any distinction between "fees" and "regulatory fees" and provided that all fees charged by an agency must be submitted to the legislature and approved an appropriations act. In the statute for this fund, the word "regulatory" was stricken from the term regulatory fee.

SB 191 (2010 GS) Modifies the name of certain funds in the code for governmental accounting purposes. Changes the name of certain funds to reflect that the fund are restricted accounts within the General Fund (including the Commerce Service Account, # 1001).
