Description:

Provides for programs that protect and defend the rights, safety, and quality of life of children. Money will be appropriated from this fund into the programs it supports. Any funds in excess of \$200,000 remaining as of June 30 of any fiscal year shall lapse to the general fund.

HB 19 (2001 GS) Renumbered the code section for the marriage license fees that go into the fund. The old section was UCA 21-2-8; the new section is UCA 17-16-21.

HB 128 (2007 GS) Established a mandatory divorce orientation course. A fee of \$5 shall be collected, as part of the course fee paid by each participant, and deposited in the Children's Legal Defense Account described in Section 63-63a-8. Note: UCA 63-63a-8 was not amended to include this \$5 fee.

SB 224 (2007 GS) Increased from \$2 to \$4 the amount that will be withheld from the existing civil filing fee collected on any complaint, petition, etc. in every court of record and allocated to the fund.

HB 78 (2008 GS) Renumbered and reorganized Title 78.

SB 204 (2013 GS) A judiciary amendments bill, but as to this account adds to the purpose of the account: "implementing and administering the Divorce Education for Children Program." Also makes technical changes.
