### Description:

The 2000 Legislature, through SB147, created the Online Court Assistance Account to fund an online court assistance program. The program will provide the public with information about civil procedures and to assist the public in preparing and filing civil pleadings and other papers.

HB 19 (2001 GS) Renumbered the code section that authorizes the court fees deposited into this fund. The old code section was 21-1-5; the new code section is 78-7-35.

HB 78 (2008 GS) Renumbered and reorganized Title 78.

SB 108 (2014 GS) Requires an additional \$20 filing fee in civil justice court cases if a person files a complaint, petition, answer, or response prepared through the Online Court Assistance Program. Also changes the filing fee for a domestic relations order.
