

RECODIFIED IMPACT FEE ACT: S.B. 146, IMPACT FEE AMENDMENTS (2011 G.S.) SUMMARY INFORMATION

SUMMARY TABLE: NEW CHAPTER 11-36a → OLD CHAPTER 11-36

The following summarizes how sections of Title 11, Chapter 36, Impact Fees Act, are addressed in new Title 11, Chapter 36a, Impact Fees Act, which takes effect May 11, 2011. The table summarizes S.B. 146 as passed by the Legislature, including amendments made during the 2011 General Session. This is not a comprehensive analysis of the recodification. The summary does not highlight when new language is added nor address actions outside of Title 11, Chapter 36a.
