15	Section 1. Section <b>36-12-5</b> is amended to read:
16	36-12-5. Duties of interim committees.
17	(1) It is the duty of each interim committee:
18	(a) to receive study assignments by resolution from the appropriate house of the
19	Legislature;
20	(b) to receive study assignments from its corresponding Senate or House Management
21	Committee, created under Section 36-12-6;
22	(c) to place matters on its study agenda upon notification to its Senate or House
23	Management Committee[. If a]; which study request if it has not been disapproved by the
24	appropriate management committee within 30 days of receipt of the request, the interim committee
25	may proceed with the requested study;
26	(d) to request research reports from the professional legislative staff pertaining to the
27	committee's agenda of study;

9	(2) Reports and recommendations of the interim committees shall be completed and made
10	public at least 30 days prior to any legislative session at which the reports and recommendations
11	are submitted. A copy of the reports and recommendations shall be mailed to each member or
12	member-elect of the Legislature, to each elective state officer, and to the state library.
13	Section 2. Section <b>36-12-7</b> is amended to read:
14	36-12-7. Legislative Management Committee Duties.
15	(1) The Senate or House Management Committee shall:
16	(a) receive legislative resolutions directing studies on legislative matters and may assign
17	these studies to the appropriate interim committee of its house;
18	(b) assign to interim committees of the same house, matters of legislative study not
19	specifically contained in a legislative resolution but considered significant to the welfare of the
20	state;
21	(c) receive requests from interim committees of its house for matters to be included on the
22	study agenda of the requesting committee. Appropriate bases for denying a study include
23	inadequate funding to properly complete the study or duplication of the work;
24	(d) establish a budget account for interim committee day as designated by Legislative
25	Management Committee and for all other legislative committees of its house and allocate to that
26	account sufficient funds to adequately provide for the work of [the committee] those committees;

2 Section 3. Section **67-1-1** is amended to read:

## 67-1-1. General powers and duties.

In addition to those prescribed by the constitution, the governor has the following powers and must perform the following duties[:].

- (1) He shall supervise the official conduct of all executive and ministerial officers.
- (2) He shall see that all offices are filled and the duties thereof performed, or in default thereof, apply such remedy as the law allows, and, if the remedy is imperfect, acquaint the Legislature therewith at its next session.
  - (3) He shall make appointments and fill vacancies as required by law.
- (4) He is the sole official organ of communication between the government of this state and the government of any other state and of the United States.
- (5) Whenever any suit or legal proceeding is pending against this state, or which may affect the title of this state to any property, or which may result in any claim against the state, he may direct the attorney general to appear on behalf of the state, and may employ such additional counsel as he may judge expedient.
- (6) He may require the attorney general or the county attorney or district attorney of any county to inquire into the affairs or management of any corporation doing business in this state.
- (7) He may require the attorney general to aid any county attorney or district attorney in the discharge of his duties.
- (8) He may offer rewards, not exceeding \$1,000 each, payable out of the general fund, for the apprehension of any convict who has escaped from the state prison, or any person who has committed, or is charged with the commission of, a felony.
  - (9) He must perform such duties respecting fugitives from justice as are prescribed by law.
  - (10) He must issue and transmit election proclamations as prescribed by law.
  - (11) He must issue land warrants and patents as prescribed by law.
- 27 (12) He must, prior to each regular meeting of the Legislature, deliver to the Division of 28 Archives for publication all biennial reports of officers, commissions, and boards for the two 29 preceding years.
- 30 (13) He may require any officer, commission, or board to make special reports to him in writing.
