14	Section 1. Section 41-1a-1101 is amended to read:
15	41-1a-1101. Seizure Circumstances where permitted Impound lot standards.
16	(1) The division or any peace officer, without a warrant, may seize and take possession
17	of any vehicle, vessel, or outboard motor:
18	(a) that the division or the peace officer has reason to believe has been stolen;
19	(b) on which any identification number has been defaced, altered, or obliterated;
20	(c) that has been abandoned on the public highways;
21	(d) for which the applicant has written a check for registration or title fees that has not
22	been honored by the applicant's bank and that is not paid within 30 days;
23	(e) that is placed on the water with improper registration; or
24	(f) that is being operated on a highway:
25	(i) with registration that has been expired for more than three months;
26	(ii) having never been properly registered by the current owner; or
27	(iii) with registration that is suspended or revoked.

1	(2) If necessary for the transportation of a seized vessel, the vessel's trailer may be seized
2	to transport and store the vessel.
3	(3) Any peace officer seizing or taking possession of a vehicle, vessel, or outboard motor
4	under this section shall immediately notify the division of the action.
5	(4) A vehicle or vessel seized under this section shall be moved by a peace officer or by
6	a tow truck that meets the standards established:
7	(a) by the Department of Public Safety under Subsection 41-6-102(4)(b); and
8	(b) under Title 27, Chapter 17, Motor Carrier Safety Act.

14	(6) (a) Except as provided under Subsection (6)(b), a person may not operate or allow to
15	be operated a vehicle stored in a public garage, impound lot, or impound yard regulated under this
16	part without prior written permission of the owner of the vehicle.
17	(b) Incidental and necessary operation of a vehicle to move the vehicle from one parking
18	space to another within the facility and that is necessary for the normal management of the facility
19	is not prohibited under this Subsection (6)(a).
20	(7) A person who violates the provisions of Subsection (6) is guilty of a class C

25	impound yard shall keep a record of every vehicle, vessel, or outboard motor stored in it for
26	compensation for a period longer than 12 hours.
27	(b) The record shall include:
28	(i) the name and address of the person storing the vehicle, vessel, or outboard motor; [and]
29	(ii) a brief description of the vehicle, vessel, or outboard motor, including the name or
30	make, identification number, and license number shown by the license plates[-]; and
31	(iii) the mileage shown on the vehicle's odometer both upon arrival at and upon its release

from the public garage, impound lot, or impound yard, if the vehicle is equipped with an odometer.

(2) Every record kept under Subsection (1) shall be open to inspection by any peace
