17	Section 1. It is proposed to amend Utah Constitution Article VI, Section 5, to read:
18	Article VI, Section 5. [Who eligible as legislator.]
19	No person shall be eligible to the office of senator or representative who [as of the last date
20	provided by law for filing for the office] is not a citizen of the United States, twenty-five years of
21	age, a qualified voter in the district from which [he] the person is chosen, a resident of the state
22	for three consecutive years [of the State] immediately prior to the last date provided by statute for
23	filing for the office, and [for six months] a resident of the district from which [he] the person is
24	elected for six consecutive months immediately prior to the last date provided by statute for filing
25	for the office. No person elected to the office of senator or representative shall continue to serve
26	in that office after ceasing to be a resident of the district from which elected.
27	Section 2. Replacing previous resolution Submittal to electors.
