14	Be it resolved by the Legislature of the state of Utah:
15	Section 1. <b>JR-4.22</b> is amended to read:
16	JR-4.22. Copies and Distribution of Bills.
17	(1) (a) A member desiring to introduce a bill shall file a Request for Legislation with the
18	Office of Legislative Research and General Counsel.
19	(b) The request shall designate the chief sponsor.
20	(c) A bill may have two types of sponsors:
21	(i) a chief sponsor who is knowledgeable about and responsible for providing pertinent
22	information as the bill is processed; and
23	(ii) supporting legislators who wish to cosponsor the bill.
24	(2) (a) When a member files a Request for Legislation, the Office of Legislative Research
25	and General Counsel shall:
26	(i) review the request and any accompanying bill; and
27	(ii) with the approval of the sponsor, prepare the legislation for introduction by making

1	any changes necessary to:
2	(A) insure that it is in proper legal form;
3	(B) remove any ambiguities;
4	(C) avoid constitutional or statutory conflicts;
5	(D) insure a uniform system of punctuation, capitalization, numbering, and wording;
6	(E) eliminate duplication and repeal of laws directly or by implication;
7	(F) correct defective or inconsistent section and paragraph structure in arrangement of the
8	subject matter of existing statutes;
9	(G) eliminate all obsolete and redundant words; and
10	(H) correct obvious errors and inconsistencies in punctuation, capitalization, numbering,
11	and wording.
12	(b) Legislative General Counsel shall indicate on the first page of the bill the drafting
13	attorney's approval of the bill.
14	(3) [(a)] The Office of Legislative Research and General Counsel shall reproduce ten
15	copies of the approved bill and deliver:
16	(a) seven of them to the Chief Clerk or the Secretary[-]; and
17	(b) [The Chief Clerk or the Secretary shall distribute] three [copies of the approved bill]
18	of them to the Legislative Fiscal Analyst for fiscal notes.
19	(4) (a) The Director of the Office of Legislative Research and General Counsel shall note
20	on any bill reviewed by an interim committee that the committee recommends the bill or has voted
21	the bill out without recommendation.
22	(b) This interim committee or note shall be printed with the bill.
23	(5) (a) Any Request for Legislation filed directly with the Office of Legislative Research
24	and General Counsel, with an accompanying bill, shall be reviewed and approved by it within
25	three legislative days.
26	(b) A legislative review note shall be attached to the bill, together with any interim
27	committee note.
28	(c) This three day deadline may be extended if the Director of the Office of Legislative
29	Research and General Counsel requests it and states the reasons for the delay.
30	(d) The legislative review letter shall be printed with the bill.
31	(6) (a) (i) When the Legislative Fiscal Analyst receives the approved bill, that office has

Compensation. 17 Legislators shall receive the compensation established in Section 36-2-2 and expenses as provided by Joint Rule. 18
