7	(d) (i) A vacancy exists whenever a committee member ceases to be a member of the
8	Legislature or when a member resigns from the committee.
9	(ii) Vacancies shall be filled by the appointing authority, and the replacement shall serve

11	(3) In conducting all of its business, the committee shall comply with the rules of

4	There is appropriated from the General Fund for fiscal year 1998-99:
5	(1) \$6,000 to the Senate to pay for the compensation and expenses of senators who are

8	are members of the task force; and
9	(3) \$63,500 to the Office of the Legislative Fiscal Analyst for staffing expenses associated

12	If approved by two-thirds of all the members elected to each house, this act takes effect
13	upon approval by the governor, or the day following the constitutional time limit of Utah
